Penn Valley Gas, Inc. of Telford, PA ("Company") and the undersigned Applicant(s) hereby agree as follows, intending to be legally bound hereby:

1. Company is hereby authorized by Applicant(s) to deliver propane to the delivery address listed above on a regular basis. Company shall estimate the rate of consumption of propane based on the size of the tank, size of the building, the temperature, and other factors, and shall make deliveries on an as needed basis without being called by Applicant(s). If Applicant runs out of propane for any reason, Company shall in no manner be liable for any damages, direct or indirect, resulting from the tank being empty. Will call customers are responsible for monitoring the tank and calling Company at least 3 business days before delivery.
2. Applicant(s) shall pay all bills from Company promptly upon receipt. If payment is not made in full within 30 days from the date of the bill, Applicant(s) shall be deemed in default and thereby authorizes Company to withhold service and charge the maximum late charge on the unpaid balance permitted by law, which is currently 1.5% per month in Pennsylvania. Applicant(s) shall be financially responsible for all collection fees and legal fees incurred by Company through the process utilized to collect an outstanding balance.
3. Company is hereby authorized to investigate all references and information listed herein, including the use of any credit-reporting agency, to make a determination on the qualifications of Applicant(s) for an account. Applicant(s) authorizes the references to release all requested account information to Company. By allowing Applicant(s) to open an account with Company, Company is not extending credit or allowing deferred payment.
